Legally have to have referendum to create a Taxation Function

Why should we pay for an airport? CRD Electoral Area: 12,772 residents City of Quesnel: 9,879 residents

Residential Tax Rate to support the airport will be \$3.65 / \$100,000.00

Option to pay a User Fee (Airport Improvement Fee)

Some would gladly pay a tax to have the airport at \$3.65 / \$100,000.00

Threat / Scare Tactics: "The lack of financial support from rural residents may result in a reduction of airport services and jeopardize the long-term viability of the airport"

"As rural ares of the N. Cariboo receive the economic and social benefits of the airport, the Cariboo Regional District is proposing a new tax for rural areas to support the airport". How does this benefit the residents of Strathnaver?

What's the question on the Referendum?

Table below displays number of properties in BL Fire Protection Boundary and 108 Mile Greenbelt

Bouchie Lake Fire Protection: Annual Budget: \$126,844

Discussion proceeded regarding the process of up a Taxation Function for "Green Spaces and Trails" using the "108 Mile Greenbelt Commission" as an example and based upon resident and tax function items for the Bouchie Lake Fire Protection

Road Safety Discussion (Highway)

David will pose the following questions to Brad Moore, Ministry of Transportation and Highways

Safety: Why do signs say slow to 70 km./hr. past the BL Hall and Rec. grounds (Provincial Highway); Dale suggests it should be 50 km. past the school; Provincial Paved Highway - minimum speed is 80 km./hr.

"60 km. Ends"????

Street Lights being installed (Nazko and Blackwater Road and Bonny Road); Cross Walk; Advanced Warning Lights (flashing lights)?

50 km. zone leading up to Cross Walk???

Trails Along the Highway: can community have legal access to the right-of-way between the highway and private land; what is the process? What about un-licensed vehicles (e.g. quads, dirt bikes, etc.) accessing this land; addresses a safety concern

Who is funding the Lights? Electricity?

Bouchie Lake Stewardship Group: no up date; sign pending approval from M. of Transportation to erect sign at Milburn Lake

Proposal to develop a Park on Bouchie Lake (on Norwood Road; west of Barker Road) 2 lots for sale on Bouchie Lake - on Norwood down from Barker Road 108 Greenbelt Commission -

DL 4509 - Lot C and Lot D - potentially low land

Discussion on the establishment of a Tax Function and creation of a Commission under the CRD (similar to the 108 Green Belt Commission)

ACTION: Dale will research details on GB Commission (Bylaw, Governance, etc.)

Right-of-Way Access to the Lake 10 Highway R/W Access to Bouchie Lake Open up access - so the community can access the lake

Extend "Bouchie-Milburn Community Park"
