Peggy Smith introduced 2 options for a Mission Statement as circulated to the TEAM members

The Mission Statement of the Bouchie-Milburn Community Planning Team is

To bring Bouchie-Milburn community residents together as involved members of the Community Planning Team. The Team will have a collaborative voice in the planning, organizing, implementing any, and all, community development and initiatives, that the either promote or hinder the growth of our immediate area. This grassroots team will work together to promote growth, inclusion, transparency, and non-partisan community involvement.

3. Airport Referendum Proposal - response from Darron Campbell (as circulated by Susan McNeill via email)

Bring forward to the CRD BoD for endorsement; no public engagement timeframe proposed;

Public consultation should be happening now by individual Directors;

Not officially approved by the CRD BoD; want to establish a Contribution Service Bylaw Implied comment on #7 - "may result in a reduction in services"; likely not going to happen

Why not an Airport Improvement Fee - User Pay

Quesnel Sky Fest Does not pay anything to use (rent) the Airport during the Air Show;

Use of the Airport for Air Ambulance, BC Wildfire, other Users - pay a user fee

CRD FAQ Sheet - very vague

As soon as something goes onto taxes, control of people's money goes away from the people

### Recommendation:

- (i) a letter be written to the CRD / City of Quesnel once we obtain additional information (see below)
- (ii) contact the City of Quesnel (Kari Boulton?) & request a copy of the Operating Budget for the Quesnel Airport; Operating Budget: \$180,000 expenses and sources of revenue (users, CMA, BC Wildfire, BC Medical (Air Ambulance), Sky Fest, Quesnel Flying Club, fuel, etc.); Isobelle will contact; HDW will email out another FAQ from the CRD
- (iii) Maximum amount under the Establishment Bylaw? \$66,000 for CRD residents??? (iv) Process within local government to re-new a Bylaw, change a Bylaw, increase the maximum, etc.??? (Ask Alice Johnston)
- (v) FAQ Sheet refers to "Longterm Viability of the Airport" 3 years is not longterm (vi) The CPT Could produce a "FACT SHEET" for distribution; Pros and Cons
- (v) Who is paying the \$180,000 now? If bylaw passes, the C. of Quesnel contribution will reduce to \$114,000; where does the \$66,000 go?
